Directors Report:

David and Tyler will continue to negotiate with them and present the results to the Board of Trustees. They will be meeting with David Boggs, Clarke Mosquito Control to discuss what products and pricing they can offer.

David will be invoicing Lamb Weston, Connell for work done in 2022. The total invoice amount will be \$22,000.00. He will work on getting a contract setup for the 2023 season.

All seasonal employees have been released for the 2022 season with fulltime staff doing final inspections throughout the County and making treatments as necessary.

Current Expense Vouchers:

David reviewed for the Board the District's September vouchers and current monthly budget, needs and purchases. The total amount of the vouchers and unpaid bills for September came to \$4,243.91 and \$60,000.00 for payroll. It was moved by John White to pay September's vouchers and seconded by Brian Cochrane. The Board voted, and the vouchers were unanimously approved.
